Acquisition of equipment

- No equipment or costume donations are being sought at this time
- Need to acquire some perusal scripts for possible musical in 2021-22 school year and this isn't budgeted for so will be asking for a budget amendment tonight to accommodate that spending amount, so we'll vote on the increase to budget for that a little later tonight
- 3. Treasurer's report:
 - We have a bank balance of \$5,764.78
 - We have raised about \$20,195 since August which is 36% of our \$55,530 budget. We are doing well in managing expenses with the limited amount of funds we have brought in. We have been successful in reducing expenses
 - We will continue to be diligent in our spending with respect to our budget.
- 4. Budget change:
 - According to our by-laws, when we have change in budget, we must hold a vote.
 - We are asking for a vote to approve a new budget line item of miscellaneous club expenses at \$100
 - We think it is appropriate to allow flexibility with respect to seeing things through to next year. This will be offset by less expenses.
 - There were no questions raised regarding the new budget line item
 - Vote taken. Approved by majority
- 5. Fundraising:
 - We have spirit nights planned on March 23 at Local Table and in April 17 at Freddy's.
 - The OAP performance on 12 March is a fundraiser.
 - In the future we will have a corporate sponsorship program
 - We continue to fundraise through AmazonSmile, FlipGive, and PaylPal Giving fund and merchandise sales on our website. Additionally, PayPal Giving does not charge us merchant fee so that maximizes the donations we receive, we receive 100% of funds. These are all linked on our website
 - FlipGive has enormous potential as they are giving millions to non profits. We can do more with FlipGive. In fact, we can maximize donations by purchasing Amazon gift cards with FlipGive then turn around and make purchases with those gift cards through AmazonSmile.
 - We are 75% through the school year and behind in fundraising as we look to raise enough for the musical Mr. Midkiff wants to do, which will cost in excess of \$20,000 next year. FlipGive has many participating retailers and there is no extra cost for participating, it is money donated to us for things you are already purchasing.
- 6. Volunteering:

- Executive board needs help with admin and organizing tasks. We are looking for volunteers to assist with some tasks to lighten our load.
- March 12- we will be looking for volunteers for box office and merchandise sales for OAP
